Location

The *International Animal Rights Conference 2015* will be held in the *Centre Culturel Kulturfabrik Esch* at 116, rue de Luxembourg, L-4221 Esch-sur-Alzette, Luxembourg.

Times

Exhibits will be open from Thursday, September 10th 2015 until Sunday, September 13th 2015. The exact times will be set several weeks before the conference, but will be roughly the following:

- Thursday: 13:30-21:30
- Friday: 9:00-20:00
- Saturday: 9:00-20:00
- Sunday: 9:00-15:30

Besides being open to conference participants, also the public can visit the exhibits.

Setup will be on Thursday, from 11:00 to 13:30 and cleanup will be on Sunday, from 15:30 to 17:30.

Exhibit Space

A standard exhibit consists of a table (height: 73cm, width: 220cm, depth: 50cm) plus two chairs. Most, but not all, exhibit locations are against walls. Spaces are assigned by the conference team, but early registrants and sponsors get the best picks. Power hookups are available with maximum 500 Watts per exhibit.

Prices

The prices are 100 EUR for a commercial exhibit (either commercial company exhibit or a group focusing on selling products) and 40 EUR for nonprofit organizations (who are mostly providing information instead of selling products). For commercial exhibits a double width stall (440cm width) costs 150 EUR and for nonprofit exhibits it costs 60 EUR.

No spaces will be held without prepayment.

Exhibit fees are refundable minus 20 EUR processing fee, if the exhibit is canceled in written form by August 1st 2015. After August 1st 2015 a refund is not possible. If *Save Animals asbl* has to cancel the exhibits due to unforeseen circumstances, its liability will be limited to the full refund of the exhibit fees.

The exhibitor price does not include a conference registration, so exhibitors wishing to participate at the conference have to register separately. Per exhibitor two full conference registrations at half the price at the time of registration, is possible.

No exhibit may be operated in a manner that detracts from the effective operation of other exhibits or the conference. Activity may not extend outside the assigned space. Attaching signs to walls and loud audio are prohibited.

The exhibit spaces will be pre-assigned and may not be changed or re-assigned without permission by the conference team. Any exhibitor violating these conditions will be offered an opportunity to make the needed correction. If the requested corrections are not met, this may lead to expulsion and forfeiture of fees.

The exhibitor agrees to hold harmless *Save Animals asbl*, the *Centre Culturel Kulturfabrik Esch*, and their employees and agents against any property or other losses or claims arising out of their use of the exhibit material and premises.
